Proposed area of Service

Borough (Boro) Park Community covers the following. (Map attached)

We start on the western side, from 60th Street and 9th Avenue. We go north past Maimonides Medical Center until 36th Street. (I block bordering Greenwood Cemetery) till Ft. Hamilton Parkway. We turn left (north) for 2 blocks until 36th Street and make a tight turn (south east) onto 14th Avenue which meets Church Avenue in the same spot. Continue on Church Avenue (north east) until you reach Coney Island Avenue. Make a right turn and go on the eastern side till you reach Avenue J. Make a left turn continue going west till you come to Bay Parkway. Make a left turn and go at an angle (south west) until you reach 65th Street. Make a left turn and go north west till you hit New Utrecht Avenue. Make a left turn continue to go for 5 blocks until you reach 60th Street and 14th Avenue. Make a left and go straight bearing west until you come to 9th Avenue. Our starting point, 9th Avenue and 60th Street.

This area includes Boro Park, parts of Kensington/ Parkville and it borders Midwood as well a Bensønhurst.
